conform to all of the requirements as set out in regulation 54 of the regulations of Western Cape Nature Conservation Board (amended by PN 37/2000). These facilities include the following:

- The escorting services of a professional hunter;
- Hunting, skinning, handling and dispatch services;
- Accommodation and washing and sanitary conveniences;
- Catering facilities;
- Transport;
- Cleaning and refuse removal services,
- First-aid and fire-fighting services, and
- Staff services.

Should these facilities be found at the time of an inspection by WCNCB not to be of the required standard as set out by WCNCB, I undertake to rectify all insufficient services. Should I refrain from doing so the WCNCB has the right to cancel any permit issued to me to act as a Hunting Outfitter.

I confirm to regulation 57(d) of the aforementioned regulations, which states that the advertisement, brochure or pamphlet by which I advertise the hunting of wild animals or feral animals will be submitted for prior written approval by the Chief Executive Officer: Western Cape Nature Conservation Board.

WESTERN CAPE NATURE CONSERVATION BOARD

On 30 July 1998, the Western Cape Nature Conservation Board agreed to the "Protocol in respect of Professional Hunters, Hunting Outfitters and Directors of Professional Hunting Schools". The following criteria were established for the registration as of Professional Hunters, Hunting Outfitters and the renewal of these permits.

In all of these cases an applicant must have passed the prescribed exams through a registered Professional Hunting School, be older than 21 years and have paid the prescribed fees.

CRITERIA TO OBTAIN A PROFESSIONAL HUNTERS PERMIT (NEW/1ST TIME)

The applicant must have:

- 4.1 Proof that he/she attended a registered Professional Hunting School and possesses the necessary knowledge, ability, skill and experience required, as well as having passed the relevant practical examinations.
- 4.2 Proof that he/she has successfully completed the theoretical examinations set by the relevant Provincial Nature Conservation Authorities. No person under the age of twenty-one (21) shall be permitted to write these examinations. Unless the applicant can submit written proof of having at least sixty, (60) days' experience hunting dangerous game or, alternatively, of being in possession of a valid professional hunter's permit before 30 March 1997, his/her professional hunter's permit will be endorsed to **EXCLUDE** the hunting of elephant, rhino, lion, leopard, buffalo and hippo.
- 4.3 Submit a written application.
- 4.4 Submitted an application within one (1) year of obtaining a certificate from the Director of the Hunting School, which he/she attended.
- 4.5 Membership of a recognised professional hunters' association.
- 4.6 Paid the provincial nature conservation permit fees.

CRITERIA TO RENEW A PROFESSIONAL HUNTERS PERMIT

- 4.7 **Renewal** of a Professional Hunter's permit will be subject to the following:
 - 4.7.1 The applicant must submit proof that he / she has undertaken (as a professional hunter) **at least three hunts** or completed **a minimum of 21** (twenty-one) hunting days with an **overseas client**, during that **three (3) year** preceding the application.
 - 4.7.2 Should the requirements of 4.7.1 not be fulfilled, the applicant must be re-tested at the discretion of the Director of a Professional Hunting School and the theoretical exams rewritten.

CRITERIA TO OBTAIN A HUNTING OUTFITTERS PERMIT (NEW/1ST TIME)

The applicant must have:

- 5.1 Proof that he / she attended a registered Professional Hunting School and possesses the necessary knowledge, ability, skill and experience required as well as having passed the relevant practical examinations (same as for Professional Hunter).
- 5.2 Proof that he/she successfully completed the theoretical examinations set by the relevant Provincial Nature Conservation Authorities. No person under the age of twenty-one (21) shall be allowed to write these examinations.
- 5.3 Proof that he/she has been an active Professional Hunter for a period of at least three (3) years.
- 5.4 Submit a written application.
- 5.5 Membership of a recognised professional hunter's association.
- 5.5 The necessary' hunting rights for the species he / she advertises for hunting in a particular province. These hunting rights must be recorded.
- 5.7 The necessary services, facilities and conveniences.
- 5.8 Submitted all promotional brochures, which describe the services, facilities, conveniences and species of animals listed under items 5.6 and 5.7 above.
- 5.9 Paid the provincial nature conservation permit fees.

CRITERIA FOR RENEWAL OF A HUNTING OUTFITTERS PERMIT

5 10 **Renewal** of a Hunting Outfitter's permit will be subject, to the following:

- 5.10.1 The applicant must submit proof that he / she has undertaken (as a hunting outfitter), at **least three (3) hunts** or completed **a minimum of twenty-one (21)** hunting days with an **overseas clients**, during **the three (3) years** preceding the application.
- 5.10.2 Should the requirements of 5.10.1 not be fulfilled, the applicant must be re-tested at the discretion of the Director of a Professional Hunting School and all theoretical exams rewritten.
