ANIMAL DISEASES REGULATIONS: AMENDMENT

The Minister of Agriculture has under section 31 of the Animal Diseases Act, 1984 (Act No. 35 of 1984) made regulations set out in the Schedule hereto.

SCHEDULE

Definitions

1. In this Schedule any word or phrase to which a meaning has been assigned in the Act, shall have that meaning and unless the context otherwise indicates -

"the Act", means the Animal Diseases Act, 1984 (Act No. 35 of 1984); and

"the Regulations", means the Animal Diseases Regulations as published by Government Notice No. R. 2026 of 26 September 1986, as amended by Government Notices Nos. R. 2208 of 24 October 1986, R. 266 of 13 February 1987, R. 2343 of 16 October 1987, R. 884 of 5 May 1988 (as corrected by Government Notice No. R. 1043 of 3 June 1988), R. 394 of 1 March 1991 (as corrected by Government Notice No. R. 931 of 3 May 1991), R. 2358 of 10 December 1993, R. 1023 of 27 May 1994, R. 254 of 6 February 1997, R. 1136 of 11 September 1998, R. 361 of 7 April 2000, R. 443 of 25 May 2001, R. 885 of 21 September 2001 (as corrected by Government Notice No. R. 1386 of 21 December 2001), R. 162 of 24 February 2006, R. 163 of 24 February 2006, R. 864 of 1 September 2006 (as corrected by Government Notice No. R. 1059 of 27 October 2006), R. 204 of 16 March 2007, R. 371 of 26 April 2007 and R. 543 of 6 July 2007.

Amendment of Regulation 1 of the Regulations

2. Regulation 1 of the Regulations is hereby amended by the insertion of the following definition in the correct alphabetical order in sub-regulation (1).
" 'grandparents poultry flock' means as a flock of parents of the parents of commercial pullets and broilers".

Amendment of Regulation 20 of the Regulations

3. Regulation 20 of the Regulations is hereby amended by:
- (a) the substitution of subregulation (1) (a) (ix) with the following paragraph:
"(ix) move or remove any warthog, bush pig or wild pig carcass, meat, skin, trophy or other product of warthog, bush pig or wild pig origin to, across or from land in the Provinces of Gauteng, Mpumalanga, Limpopo, North West or KwaZulu-Natal".
 - (b) the substitution of subregulation (3) with the following text:
"A permit referred to in subregulation (1) for the movement or removal of buffalo shall be issued only if the land to which those buffalo are to be moved or removed are registered as contemplated in regulation 20A. Such a permit shall be restricted by the provision made in Regulation 20 (6)".

- (c) the insertion of the following text after subregulation (5):
 "(6) No permit shall be issued for the movement or removal of live buffalo out of the controlled areas for Corridor or Buffalo disease or the infected zone and buffer zone portions of the controlled areas for Foot and mouth disease as described in Table 1. Any exemption for this provision in terms of Regulation 11(2) (a) and (b) may be granted only subject to written approval of the director referred to in section 2(1) of the Act".

Amendment of Regulation 20B

4. Regulation 20B is hereby amended with the substitution of the whole text under Regulation 20B with the following text:

"Keeping of Equines and Zebra in the African Horse sickness controlled area"

- 20B. (1) No person shall keep equines on any land in the African Horse sickness free zone as described in Table 1, unless such equines and land are registered with the director for this purpose".
 (2) No person shall keep zebra on any land in the African Horse sickness free zone and the African horse sickness surveillance zone and the African Horse sickness protection zone as described in Table 1, unless such zebra and land are registered with the director for this purpose".
 (3) No equine or zebra in the African Horse sickness free zone and surveillance zone as described in Table 1, may be vaccinated for African Horse sickness without the written permission of the director".
 (4) All equines in the African horse sickness protection zone, as described in Table 1, shall be vaccinated against African Horse sickness as contemplated in column 4 of Table 2 opposite the controlled animal disease 'African Horse sickness'".

Amendment of Regulation 30

5. Regulation 30 is hereby amended by the substitution of whole text under Regulation 30 with the following:

"Compensation [19]"

30. When compensation is payable to a responsible person in terms of section 19 of the Act, the applicable compensation shall be determined by the director".

Amendment of Annexure 3 of the Regulations

6. Annexure 3 of the regulations is hereby amended by:

- (a) the insertion of the expression "Bovine Malignant Catarrhal Fever" in the correct alphabetical order.
 (b) the insertion of the expression "Strangles" in the correct alphabetical order.

Deletion of Annexure 4 of the Regulations

7. Annexure 4 of the Regulations is hereby deleted.

Amendment of Table 1 of the Regulations

8. Table 1 of the Regulations is hereby amended by:

- (a) the substitution of the expression "Afrikaanse Varkpes" in column 1 with the expression "Afrika Varkpes".
 (b) the substitution of all paragraphs in column 2 opposite the controlled animal disease "Foot and mouth disease" in column 1 with the following paragraphs:

"(a) Kruger National Park Foot and mouth disease infected zone:

The whole area of the Kruger National Park and adjacent management areas.

(b) Limpopo Province Foot and mouth disease infected zone:

- (i) That portion of the Local Municipality of Musina in the Vhembe District Municipality including the following farms: Vrouwensbron 80 MT, Popallin 87 MT, Malala Drift 83 MT (Nyathi Ranch 94 MT) and Bali 84 MT excluding the southern portion west of Route D1942.
 (ii) That portion of the Local Municipality of Mutale in the Vhembe District Municipality including the Makuya Park.
 (iii) That portion of the Local Municipality of Thulamela in the Vhembe District Municipality including the Makuya Park.
 (iv) That portion of the Local Municipality of Kruger National Park in the Kurger National Park District Municipality including the Matshakatini area north of the international border fence and the Makuleke Private Nature Reserve.
 (v) That portion of the Local Municipality of Greater Giyani in the Mopani District Municipality including the Mbaula Ranch.
 (vi) That portion of the Local Municipality of Ba-Phalaborwa in the Mopani District Municipality including the Letaba Ranch, and the following farms:
 Belasting 7 LU, Leeuwkop 10 LU, Northern portion of Baderoukwe 11 LU, N' Dole 12 LU, Sable 13 LU, Pompey 16 LU, Genoeg 15 LU, Silongwe 23 LU, Schiettocht 25 LU, Laaste 24 LU, Wegsteek 30 LU, excluding the northwest corner described by Industrial area, Extension 5 Phalaborwa on the east and west by road D86, Looie 31 LU, Merensky 32 LU, Schalk 3 KU, Paul 7 KU, Rhoda 9 KU, Sheila 10 KU, Punt 151 KT, Morelag 5 KU, Grieltjie 6 KU and Doreen 8 KU.
 (vii) That portion of the Local Municipality of Maruleng in the Mopani District Municipality including the following farms:

Try 153 KT, Square 150 KT, and all farms and portions of farms east of the tar road R40 up to and including the farm Fleur De Lys 194 KU.

(c) Limpopo Province Foot and mouth disease buffer zone:

 - (viii) That portion of the Local Municipality of Greater Tzaneen in the Mopani District Municipality including the District of Bolebedu, the District of Ritavi 1, the farm Deeside 733 LT and all farms and portions of farms to the north east of the dirt road D202 between Deeside and Rubbervale.
 - (ix) That portion of the Local Municipality of Ba-Phalaborwa in the Mopani District Municipality including all farms or portions of farms as well as other districts, east of the Deeside Rubbervale dirt road C202 up to the western boundary of the farm Gravelote 783 LT and all farms or portions of farms as well as other districts, to the north of the tar road R71 and R526 between Letsitele and Mica to the farm Transport 145 KT.
